WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES ENTITIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. Eligibility. The “Strawberry Shortcake” Game Night Sweepstakes (the “Sweepstakes”) is open only to individuals who are legal residents and physically located in **one (1) of the fifty (50) states in the United States or the District of Columbia** who are at least the age of majority or older at the time of entry. Employees, officers and directors of *Shortcake IP Holdings* (“Sponsor”), its parent, and each of their respective affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers (collectively, the “Sweepstakes Entities”), and each of such employees’, officers’ and directors’ immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to enter the Sweepstakes or win a prize. By submitting your information and creating an Instagram Account however, entrants will be required to agree to the Instagram terms of service and privacy policy. If you do not agree to Instagram’s terms of service and privacy notice, you cannot create an Instagram Account or participate in this Sweepstakes via Instagram. After entrant has an Instagram Account, log-in to your Instagram Account, and become a follower of the following Instagram Account: **@strawberryshortcake**. To enter, during the Entry Period, follow the call-to-action provided in any advertising for the Sweepstakes on how to receive an entry. The call-to-action for this Sweepstakes may require entrants to “follow” the **@strawberryshortcake** Instagram Account, as well as use the “Reply” functionality to “tag” another user (your ‘Berry Bestie’). Sponsor may not receive entries that fail to strictly follow the posting instructions set forth in these Official Rules and Sponsor is not responsible for failure to see or receive an entry. **NOTE: Sponsor may not receive entries from Instagram users with “private” account settings (i.e., user has set their Instagram Account so that only people the user has approved can view their photos) due to the way Instagram operates its service.** By “following” the

@strawberryshortcake Instagram Account and “tagging” another user in the post, entrants are confirming their acceptance and agreement to these Official Rules.

Limit of **1 (one)** entry per person (regardless of method) will be accepted. Entrants will not be automatically entered into the Sweepstakes by only clicking on the “Like” button. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Illegible and/or incomplete entries and entries submitted by entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. Sponsor may run multiple campaigns, contests, sweepstakes or other promotions simultaneously. Entry into one (1) campaign, contest or sweepstakes does not constitute entry into any other.

4. Winner Selection and Prize Claiming. There will be two (2) winner(s) selected in this Sweepstakes. The potential winner(s) will be selected through a random drawing on or about April 21, 2026, from all eligible entries received in accordance with these Official Rules. Sponsor will have complete discretion over interpretation of the Official Rules, of administration of the Sweepstakes, and of selection of the winner(s). Decisions of the Sponsor as to the selection of the winner(s) will be final. The potential winner(s) will be notified using the information provided during entry by any of email and/or telephone and/or mail and/or a post on the potentially winning entry (as selected by Sponsor) in a commercially reasonable time after the drawing. The Sweepstakes Entities are not responsible for false, incorrect, changed, incomplete or illegible contact information. Notification is deemed to have occurred immediately upon sending of an email, message via Instagram direct messaging or tag/mention in Instagram post by **@strawberryshortcake** Instagram Account announcing the winner(s), placing of a phone call, one (1) day after sending via a delivery service or two (2) days after mailing. The **@strawberryshortcake** Instagram Account is the only verified contactor of potential winners in the first instance. A potential prize winner who provides a P.O. The Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Meta, or Instagram. Entrants understand that you are providing your information to Sponsor and not to Meta, or Instagram. Information collected via the Application will be subject to Sponsor's Privacy Policy posted at <https://www.wildbrain.com/privacy-policy> well as the privacy policy posted on the Application. Any questions, comments or complaints regarding this Sweepstakes or to request to have your information be deleted from Sponsor's records shall be directed to the Sponsor at the address below and not to Meta, or the Application.

12. Governing Law / Limitation of Liability. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of **the State of California**, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

13. Dispute Resolution.

The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in Los Angeles County, California and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("**JAMS**") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("**AAA**") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Los Angeles, California. The federal or state law that applies to these Official Rules will also apply during the arbitration.
